Trial of two generics of the following formulary products: bupropion, mirtazapine, citalopram, desvenlafaxine succinate ER, duloxetine, escitalopram, fluoxetine, fluvoxamine, paroxetine, sertraline, venlafaxine. Step applies to new starts only. Approve for continuation of prior therapy.

Trial of allopurinol

ATYPICAL ANTIPSYCHOTICS - SCORE

MEDICATION(S) SUBJECT TO STEP THERAPY

CRITERIA

Trial of two of the following generic formulary atypical antipsychotic agents: aripiprazole, olanzapine, paliperidone, quetiapine, risperidone, ziprasidone. Step applies to new starts only. Approve for continuation of prior therapy.

DPP4 INHIBITORS - SCORE

MEDICATION(S) SUBJECT TO STEP THERAPY

CRITERIA

Trial of one of the following generic formulary metformin or metformin combinations: metformin, glipizide-metformin, glyburide-metformin, pioglitazone-metformin

EPINEPHRINE - SCORE

EPINEPHRINE 0.15 MG AUTO-INJECT, EPINEPHRINE 0.3 MG AUTO-INJECT

Trial of Amitiza and lactulose

RHO KINASE INHIBITORS - SCORE

CRITERIA

Trial of one of the following generic formulary metformin or metformin combinations: metformin, glipizide-metformin, glyburide-metformin, pioglitazone-metformin
